This was spotted in a local paper Amateur radio buffoon Police Sgt recently, we wonder, are they by any William Bowden got an on-air chance related?



Amateur Radio Observation Society A.R.O.S.

The A.R.O.S. is an organisation funded by subscriptions to the R.S.G.B.Ltd., We want any details of this organisation that you may have. Headed by a foul-faced old fart (as seen on BBCTV recently, thank god it was only a fleeting glimpse) they seem to be carrying out the work of the D.T.I. for them, but not without a certain amount of bias and conspiracy. We know of two amateurs that have written letters of complaint to A.R.O.S. after being fobbed off by the D.T.I., in neither case was any action taken, or any acknowledgement given to the letters. In another case, the A.R.O.S. contacted a well known local radio enthusiast and "threatened" dire retribution, when asked what was complained of and on what dates (so he could consult his log book) no reply, save a postcard stating that a further reply would be sent, was ever received - despite follow up letters. The address and function of these people are published in a D.T.I. leaflet entitled "Abuse of Amateur Radio" (RA198) It seems the A.R.O.S. are abusing what little power they think they have. We hope to print a story about them next month, with pictures! WATCH THIS SPACE, let us have any information and copies of any correspondence as soon as possible.

REPEATER NEWS

There still seems to be concerted effort by certain individuals to "censor" traffic on the GB3CF repeater. Please log it all down, in the remarks column of your log book, and do please keep a log book. There are certain people at the D.T.I. who would relish the chance of catching anyone with an incomplete log book and closing the station for log book inaccuracies, this has been done in the past! Several people have been keeping a log of the offending stations, and the same few call signs keep occurring time and time again it. We need to be able to take our complaint to the authorities backed up with as many independent reports as possible, so even if you are just listening, and you hear others attempting to make calls when the repeater is obviously in use, just log the date, time, and call sign. THE MORE CORROBORATING EVIDENCE THE BETTER. There are those of us that will not rest until ALL the abusers of the repeaters are dealt with in the same way. We will not suggest the stations we think are to blame as we want genuine reports so as to add weight to our complaint when the time comes, which it will! Those who appear immune from prosecution will have to modify their behaviour shortly, and the D.T.I. officials can no longer sweep complaints "under the carpet", thanks to the provisions of the Citizens Charter.



LEGAL NEWS


We know that many of you attended Dudley Magistrates recently to hear the case of the D.T.I. vs G7GDR, well it ended in a draw - rather like George's case, but in a slightly different way. George was charged with 10 offences and found guilty of 5, 50% success for the D.T.I., or as I heard him describe it later "I challenged them to a battle of wits, and proved they were only half prepared". With G7GDR the outcome was slightly different, $\hat{3}$ charges were made and the magistrates returned a guilty verdict on all 3, BUT with the subtle difference, giving a conditional discharge! This meant that NO FINE was imposed WHATSOEVER! The D.T.I. asked for £3910.00 towards the costs of prosecution, the magistrates decided that £1000.00 was more suitable, and ordered this to be paid over 4.77 years! It is nice to know that our licence fees are spent so wisely. With just over 60,000 licensed radio amateurs in the British Isles, the Radiocommunications Agency has around £900,000.00 to throw around (after you take off the administration costs for S.S.L., who now provide the licences on behalf of the D.T.I.) MONEY WELL SPENT? Lester Maddrell & Co. would agree, they prosecute Wireless Telegraphy Act cases for the D.T.I. and do very well out of it!
